June 15, 2020

The City Council of the City of Mesa met in a Study Session Meeting via a virtual format streamed into the City Manager's conference room, on June 15, 2020 at 5:30 p.m.

Mayor Giles conducted a roll call.

(Items were discussed out of order, but for purposes of clarity will remain as listed on the agenda.)

1. Review and discuss items on the agenda for the June 15, 2020 Regular Council meeting.

All of the items on the agenda were reviewed among Council and staff and the following was noted:

Conflict of interest: None

Items removed from the consent agenda: 4-e through 4-h, and 5-d.

In response to a question posed by Councilmember Whittaker regarding Item 5-d, (Adopting a pension funding policy and accepting the employer's share of assets and liabilities under the Public Safety Personnel Retirement System as required by A.R.S. §38-863.01. (Citywide)), on the Regular Council meeting agenda, Treasurer Ryan Wimmer explained the City officially switched from the 20-year amortization to the 30-year amortization, with an intended payoff in 25 years. He stated for the City to pay off the liability five years early, the contribution is an extra \$5 million.

Councilmember Whittaker requested that Agenda Item 5-d be removed from the consent agenda because he does not feel the City should be paying more interest on the amortization.

In response to a question from Councilmember Duff regarding Item 6-a, (ZON19-00805 (District 6) Ordinance. Within the 10600 to 11000 blocks of East Williams Field Road (south side);

within the 6000 to 6200 blocks of South Signal Butte Road (west side); and within the 6000 to 6400 blocks of South Signal Butte Road (east side). Located south of Williams Field Road on the east and west sides of Signal Butte Road (89± acres). Rezone from RS-9-PAD, RS-6-PAD, RSL-2.5-PAD, RM-2-PAD and LC-PAD to GC-PAD; A Council Use Permit to allow 100% residential uses on the first floor within a General Commercial zoning district; and modification of the Destination at Gateway PAD to remove 89± acres. This request will allow a mixed-use development. Sean Lake, Pew & Lake, PLC, applicant; Signal Butte 24, LLC, owner.), on the Regular Council meeting agenda, Mr. Brady introduced Planning Director Nana Appiah, who displayed a PowerPoint presentation. (See Attachment 2)

Mr. Appiah stated the item contains two requests: One, to change the General Plan amendment character designation from residential uses to a community activity center to allow commercial uses; and two, to change the accompanying zoning case from residential to general commercial.

Mr. Appiah highlighted the site that is requesting rezoning, stating the purpose is to allow a mixeduse development. (See Pages 3 and 4 of Attachment 2)

Mr. Appiah reported the proposed General Plan amendment is requesting to switch from neighborhood to a mixed-use activity center, which is basically for large commercial uses within the surrounding community. (See Page 5 of Attachment 2)

Mr. Appiah stated the requested zoning will be general commercial to allow the intended property use. He remarked there will be a Planned Area Development (PAD) because certain uses are restricted, and there will also be a development agreement. He mentioned in addition to the incentives, there will be land use restrictions with a percentage of required commercial. He stated the zoning ordinance requires 40% minimum commercial with a maximum of 60% residential, and this development agreement will be a minimum of 60% commercial and 40% residential. (See Page 7 of Attachment 2)

Mr. Appiah identified the Council use permit is to allow the developer to build multi-family on the ground floor and waive the requirement of 65% commercial on the ground floor. (See Page 8 of Attachment 2)

Mr. Appiah advised staff recommends approval because the plan meets the General Plan goals and the requirements of the zoning ordinance. (See Page 9 of Attachment 2)

Councilmember Duff indicated she is confused why the City would rezone general commercial and then have a Council use permit for 100% residential.

Councilmember Thompson explained the overall plan has eliminated housing in the area and created more jobs, but the trade-off is to allow some housing. He stated the developer was asked to develop vertical rather than horizontal, which is the reason for the multi-family residential component on the ground floor.

Mr. Brady expanded by saying this development allows the City to go from residential to commercial at a significant intersection in Mesa. He added the City is attempting to generate high value retail commercial activity in this area.

In response to a question from Mayor Giles regarding what the proposed use for the property will be, Mr. Brady acknowledged the City is working with the Berge family on a car dealership to establish a site thereby avoiding competing dealership locations going in the same area.

Councilmember Thompson expanded by saying only so many dealerships are allowed within a certain mile radius and Berge wants to be the first to get the prime location.

In response to a question from Councilmember Whittaker regarding whether the City is using the Government Property Lease Excise Tax (GPLET) or any tax incentives for the development, Mr. Brady clarified Item 6-a is introducing the ordinance and 6-b is giving notice that the City is considering providing a retail incentive for the car dealership, and at a future date staff will come back to Council with a plan where the City would reimburse the developer with a portion of the sales tax for a period of time for the street improvements.

In response to a question from Vice Mayor Freeman, Councilmember Thompson replied the developer is looking to purchase the land the first or second week of August to get their certificates in place and be ready to move forward.

Mayor Giles thanked staff for the presentation.

2. Take action on the following appointments.

2-a. Appointments to various Boards and Committees.

It was moved by Councilmember Thompson, seconded by Councilmember Luna, that the Council concur with the Mayor's recommendations and the appointments be confirmed, with the clarification that the terms expire in 2023. (Attachment 1)
