1. Items from citizens present.

2. Approval of minutes from the June 17, 2019 meeting.

It was moved by Boardmember Heredia, seconded by Boardmember Duff, that the minutes from the June 17, 2019 Cadence Community Facilities District Board meeting be approved.

Chairman Giles declared the motion carried unanimously by those present.

3. Conduct a public hearing on the following feasibility report.

3-a. Conduct a public hearing on the feasibility report for a proposed project to be financed by the issuance of general obligation bonds of the Cadence Community Facilities District.

Mayor Giles announced that this is the time and place for a public hearing regarding the feasibility report for a proposed project to be financed by the issuance of general obligation bonds of the Cadence Community Facilities District.

There being no citizens present wishing to speak on this issue, the Chairman declared the public hearing closed.

4. Take action on the following resolutions:

4-a. Approving the feasibility report relating to the acquisition and financing of certain improvements benefiting the Cadence Community Facilities District; declaring its preliminary intention to issue general obligation bonds, in an amount not to exceed \$1,500,000, to finance the acquisition of certain improvements as described in the feasibility report and pursuant to the provisions of Title 48, Chapter 4, Article 6, Arizona Revised Statutes.

It was moved by Boardmember Heredia, seconded by Boardmember Duff that Resolution No. CFD CD Res. 24 be adopted.

Upon tabulation of votes, it showed:

Chairman Giles declared the motion carried unanimously by those present and Resolution No. CFD CD Res. 24 adopted.

4-b. Authorizing the issuance of general obligation bonds, series 2019; approving the form and authorizing the execution and delivery of various documents related thereto; ratifying and approving a preliminary official statement and approving a final official statement relating to the bonds; levying an ad valorem tax on taxable property in the district; awarding the bonds to the purchaser thereof; appointing a registrar, transfer agent and paying agent for the bonds; and taking other actions securing the payment of and relating to the bonds; and adopting written tax compliance procedures related to the District's tax-advantaged obligations.

It was moved by Boardmember Heredia, seconded by Boardmember Duff that Resolution No. CFD CD Res. 25 be adopted.

Upon tabulation of votes, it showed:

Chairman Giles declared the motion carried unanimously by those present and Resolution No. CFD CD Res. 25 adopted.
