#### Informational Update on Recent Parking Prohibitions:

Approved on January 31, 2013 – to accommodate existing traffic signals and allow on street parking and to update existing parking prohibitions in the traffic regulation database to reflect current field conditions.

- On Eagle Crest Drive from Power Road to Ridgecrest (rescind) (east of Power Road and north of McDowell Road, Council District 5).

- On Eagle Crest Drive from Power Road to Red Mountain (new) (east of Power Road and north of McDowell Road, Council District 5).
- On Mountain Ridge from Eagle Crest Drive to Ridgecrest (rescind) (north of McDowell Road and east of Power Road, Council District 5).
- On Red Mountain from Eagle Crest Drive to Ridgecrest (rescind) (north of McDowell Road and east of Power Road, Council District 5).
- On Ridgecrest from Eagle Crest Drive to McDowell Road (rescind) (north of McDowell Road and east of Power Road, Council District 5).
- On Ridgecrest from Red Mountain to McDowell Road (new) (north of McDowell Road and east of Power Road, Council District 5).
- On Saddleback Street from Eagle Crest Drive to Mountain Ridge (rescind) (east of Power Road and north of McDowell Road, Council District 5).

Approved on February 25, 2013 – to address school related traffic congestion.
