If those signs were not there, people would be going 50 miles an hour through there and I would greatly fear another death would happen.

The noise is one, there are squeaky brakes, squealing tires, etc. It has been proven that on either side of the stop sign, people are still speeding--so it hasn't stopped the speeding. She claims the air pollution is greater because of the stop and start of cars. It can be dangerous because people don't really stop sometimes.

But the bottom line for me is, I still feel like our children are safer in that area because the speed has been cut. I don't know of anything else that we can do. We do not qualify for speed humps because it is a wider street. So I am fighting to keep the signs. We need neighborhood support if you want to keep the signs.
