#### 2. Hear reports on meetings and/or conferences attended.

Councilmember Somers: Ribbon cutting ceremony at rebuilt Mesa home equipped with fire sprinkler system

Councilmember Finter: Ride-along with Mesa Police Department SWAT Team

Police Chief Frank Milstead addressed the Council and reported that Councilmember Finter failed to mention that during his ride-along with the SWAT Team, he saved a woman who had stopped breathing by providing CPR. He explained that once the woman was able to breathe on her own, she was transported to the hospital for further treatment. Chief Milstead expressed appreciation to Councilmember Finter for his quick thinking and professionalism in this regard.

Mayor Smith congratulated Councilmember Finter for his efforts.

3. Scheduling of meetings and general information.

City Manager Christopher Brady stated that the meeting schedule is as follows:
