The proposed activities that will be undertaken as part of the Substantial Amendment are:

### A New Leaf, East Valley Men's Center Improvements

\$262,000

• Expansion and repair bathrooms, relocate the laundry room and replace the air conditioning unit at the shelter.

# City of Mesa, Demolition Program

\$50,000

Elimination of spot blight Citywide.

#### City of Mesa, Downtown Façade Improvement Program

\$100,000

 Planning and design costs for the replacement of existing colonnades and the implementation of a façade improvement program in partnership with Housing and Community Development and Mesa Downtown Merchants Association.

# City of Mesa, Kleinman Park Improvements

\$250,000

 Design and rehabilitation of the playground. New play equipment will be installed in the existing play pit, along with all new playground surfacing, and the installation of a new shade structure with integral lights over the playground. An ADA-compliant ramp will be added into play pit to increase accessibility.

# Paz de Cristo, Facility Improvements

\$64,176

 Improvements that will address health and safety issues including the repair of warehouse walls and adding additional insulation, installation of an air curtain in the food preparation area, replacement of the air conditioning unit and the addition of a canopy that provides exterior shelter for guests that eat at the facility.

The City of Mesa does not anticipate funding any projects that result in the displacement of any persons; however, should it do so, the City of Mesa will strictly adhere to the Acquisition and Relocation Policies as put forth in its Citizen Participation Plan for the FY 2015/2019 Consolidated Plan.

At this public hearing, staff will obtain views from citizens, non-profit agencies, neighborhood associations, residents of assisted housing and other interested parties concerning the CDBG activities to be undertaken with federal funds. The public hearing process allows residents to actively participate in the priority setting process by providing feedback regarding the City of Mesa's Substantial Amendment for the Program Year 2016/2017 Annual Action Plan. All interested City of Mesa residents are encouraged to attend.

Funding for the above mentioned federal program is provided by the U.S. Department of Housing and Urban Development (HUD) and used for housing and community development activities that primarily benefit low- and moderate-income persons.
