Citizens of the City of Mesa are urged to attend a public hearing conducted by the City of Mesa Housing and Community Development Division to discuss potential projects and activities for its Program Year 2016-17 Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and Human Services programs.

The expected amount of eligible funds for these programs will be discussed as well as the range of activities that may be undertaken concerning these programs. The City of Mesa does not anticipate funding any projects that result in the displacement of any persons; however, should it do so, the City of Mesa will strictly adhere to the Acquisition and Relocation Policies as put forth in its Citizen Participation Plan for the FY 2015-2019 Consolidated Plan.

At this public hearing staff will obtain views from citizens, non-profit agencies, neighborhood associations, residents of assisted housing and other interested parties on housing, homeless, community development and economic development needs to be undertaken with federal funds. The public hearing process allows residents to actively participate in the priority setting process by providing feedback regarding the City of Mesa's potential projects for its Program Year 2016-17 Annual Action Plan. All interested City of Mesa residents are encouraged to attend.

Funding for the above mentioned federal programs (CDBG and ESG) are provided by the U.S. Department of Housing and Urban Development (HUD) and used for housing and community development activities that primarily benefit low- and moderate-income persons and assist in the prevention or elimination of slum or blighting influences.

Funding for the Human Services programs comes from the City's general fund and the ABC program consisting of donations from the general public made through their utility bill payments. These funds support programs and services that directly impact community safety services and encourage independence and self-sufficiency so that residents can fully realize economic and social opportunities.

FY 2016/17 Application Presentations The Board evaluated presentations from applicants requesting funding for the City of Mesa's FY 2016/17 Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and Human Services programs. Each applicant presented proposals in the order as listed on the March 3rd, 2016 Presentation Schedule (see Attachment B).
