Informational Update on Recent Parking Prohibitions:

Approved on June 25, 2013 – to improve intersection visibility.

- On Inverness Avenue from Sunview to a point 185 feet west of Sunview (new) (north of Baseline Road and west of Recker Road, Council District 2).

Approved on June 26, 2013 – to improve driveway visibility.

- On Dana Avenue from Stapley Drive to a point 210 feet east of Stapley Drive (new) (south of Main Street and east of Stapley Drive, Council District 4).

Approved on August 13, 2013 – to address nuisance conditions as requested by adjacent property owners.

- On Hermosa Vista Drive from a point 1,300 feet west of Sossaman Road to a point 1,760 feet west of Sossaman Road (new) (north of McKellips Road and west of Sossaman Road, Council District 5).
