

COUNCIL MINUTES

August 26, 2013

The City Council of the City of Mesa met in a Study Session in the lower level meeting room of the Council Chambers, 57 East 1st Street, on August 26, 2013 at 4:32 p.m.

1. Review items on the agenda for the August 26, 2013 Regular Council meeting.

All of the items on the agenda were reviewed among Council and staff and the following was noted:

2. Discussion and selection of District 5 Council position applicants to be interviewed.

Mayor Smith stated that the Council received applications from 21 citizens who were interested in serving as the District 5 Councilmember. He explained that there were questions with respect to several applications related to residency, voter registration and other matters.

In response to a question from Councilmember Richins, City Attorney Debbie Spinner clarified that during the last Council redistricting process in Mesa, the lines for the various Council districts were modified. She explained that per the City Charter, a person must be a resident of the Council District in which they are applying to represent for the two years immediately preceding submitting an application. She stated that if an applicant, for instance, initially resided in a different district, but due to redistricting was now a resident of District 5, in her opinion, that individual would be eligible.

Mayor Smith commented that the Council, per the City Charter, is "the arbiter" of the qualified electorate and can make the ultimate determination. He pointed out that one of the citizens who submitted an application lived in District 5, the boundary lines were redrawn, which made the person a resident of another district, and the individual moved back into District 5.

Mayor Smith cited, by way of example, if someone lived in District 2, the boundaries were redrawn and the person now lived in District 3, he would find it absurd that the person would be ineligible to run in District 3 since the lines were redrawn and the individual had not lived in District 3 for two years. He noted, on the other hand, if someone lived in District 2, that individual could not run for office in District 5.

Mayor Smith said that the Council will revisit this item subsequent to convening an Executive Session, at which time they will narrow the list of applicants and determine how many interviews they wish to conduct at the September 5, 2013 Study Session.

Mayor Smith advised that during the Executive Session, the Council reviewed the 21 applications and determined that they would interview four applicants.

It was moved by Councilmember Kavanaugh, seconded by Councilmember Somers, that the four candidates the Council will interview include the following: Ms. Kevin Ruegg, Ms. Kathleen Rahn, Ms. Debra Duvall and Mr. David Luna.

Carried unanimously.

Mayor Smith reiterated that at the September 5, 2013 Study Session, the four candidates will be interviewed. He also noted that at a September 12, 2013 Special Council meeting, the Councilmembers will make their final determination with respect to the appointment of a District 5 Councilmember.

It was moved by Councilmember Somers, seconded by Councilmember Kavanaugh, that receipt of the above-listed minutes be acknowledged.
