Chief Financial Officer Michael Kennington discussed item 4-c (Three-Year Term Contract for Comprehensive Banking Services) on the Regular Council Meeting agenda.

Director of Development and Sustainability Christine Zielonka and Business Services Director Ed Quedens spoke on item 4-k (Purchase of a Replacement Development Information Management Enterprise Solution).

Transit Director Jodi Sorrell displayed a PowerPoint presentation (See Attachment 1) and discussed item 5-b (Approving and authorizing the City manager to enter into a Transportation Project Advance Agreement with Valley Metro Rail, Inc., Maricopa Association of Governments and the City of Phoenix for funding of design, right-of-way, construction and vehicle acquisition for the Gilbert Road Light Rail Extension using Transportation Project Advancement Notes (TPANs) on the Regular Council Meeting agenda. She also introduced Chief Financial Officer Michael Kennington, Sarah Smith of Gust Rosenfeld, the City's Bond Counsel, and Larry Givens of Wedbush Securities, the City's Financial Advisor, who were prepared to assist with the presentation.

Mesa Gateway Senior Project Manager Scot Rigby displayed a PowerPoint presentation (See Attachment 2) and provided a brief overview of item 5-d (Approving and authorizing the City Manager to enter into the Amended and Restated Joint Powers Airport Authority Agreement with the Phoenix Mesa Gateway Airport Authority (PMGAA) and the Town of Queen Creek, Town of Gilbert, Gila River Indian Community, City of Apache Junction, City of Phoenix (the "Members") to officially re-characterize the Members loans to PMGAA as cumulative appropriations) on the Regular Council Meeting agenda.

Transportation Project Advancement Gilbert Road Light Rail Extension Agreement



City Council Study Session December 4, 2014

Background

- 2009 Council priority to extend LRT to Gilbert Road
- 2009 Alternatives Analysis for Central Main also includes
- Road recommendation to extend light rail transit (LRT) to Gilbert
- 2011 Council approves funding for Planning Study
- 2012 Council approves funding the Environmental Assessment
- 2013 Environmental Assessment receives Finding of No Significant Impact (FONSI) by Federal Transit Administration

Why a Priority?

- Provides better use of limited transportation dollars
- Increases ridership in Mesa by 40 percent
- Provides better access from L202, US 60, as well as central and east Mesa
- Provides opportunity for redeveloping portions of Main Street from just east of Mesa Drive to Gilbert Rd
- Provides for a long-term park & ride lot at Gilbert Road
- access to growing regional LRT system Improves transit access for nearby residents with

Project Status

- Spring 2013, Gilbert Road Extension added to MAG Regional Transportation Plan (RTP)
- Fall 2014, Preliminary Engineering to be completed
- Fall 2014, start early Project development including:
- Procure design consultant & Construction Manager at Risk
- Initiate final design and real estate acquisition
- Other pre-construction services and Project activities
- Summer 2015, complete Early Project Development
- Next step is to begin the procurement for a designer
- and Construction Manager @ Risk (CMAR)

Project Financing Scenario

- Mesa to issue Transportation Project Advancement Notes (TPANs) to advance funds for Project
- Similar to financing used to advance Gateway Freeway (State Route 24)
- Mesa to retire notes with repurposed federal years 2016 to 2024 transportation funds in MAG RTP from federal fiscal
- Mesa's local match will be funded by existing transportation resources

Project Funding Agreement

- The Transportation Project Advance Agreement to extend LRT to Gilbert Road Transportation Project Advancement Notes (TPANs) (Agreement) provides terms for issuing the
- The agreement is between Mesa, METRO, Phoenix and MAG
- Anticipate approval by all parties by early 2015
- Council resolution needed in order to issue the first series of TPANs; possibly in Spring of 2015

Overview of Agreement

- IGA identifies administrative responsibilities:
- METRO administers design and construction
- Phoenix serves as designated grant recipient
- MAG assists in flexing federal funds for Project
- Mesa works with all agencies, acquire right-of-way
- Establishes financing for Project
- Provides City control of expenditures through requisitions & annual budget

Project Budget

- Project cost estimate is \$161.7 million for design, expense right-of-way, construction, LRT vehicles and interest
- million Revenues programmed for the Project are \$164.7
- Revenues exceed estimated Project costs by about \$2.9 million
- **Issuing TPANs** set aside for this Project for expenditures prior to MAG has advanced \$5.4 million of the RTP funding

TPAN Financing

- the Project City Financial Advisor developed cash flow for financing
- <u>\$139.3 million in TPANs proposed to be issued</u>
- Issuance amount less than total Project cost due to:
- Receipt of some of the federal transportation funds during the Project,
- Use of MAG advances prior to issuing TPANs
- fund final design, right of way and other project activities First series of TPANs to be issued in summer/fall 2015 to
- Second series of TPAN issued in July 2016 for construction
- Interest expense estimated to be \$14.7 million

Next Steps

- agreement Authorize City Manager to enter into TPAN funding
- Complete early Project development activities as funded with MAG advances through June 2015
- 2016 Issue first series of TPANs in June 2015 to fund right-ofway, design and other Project activities through June
- Receive guaranteed maximum price for the Project from Construction Manager @ Risk contractor
- Issue second series of TPANs in July 2016 to fund construction/remainder of Project

History

- Former Williams Air Force Base

- Apache Junction, Gilbert, Gila River Indian Community, Mesa, Phoenix and Queen Creek
- These six communities jointly guide, govern, invest and support the Airport's growth
- Each community invests annually at various levels

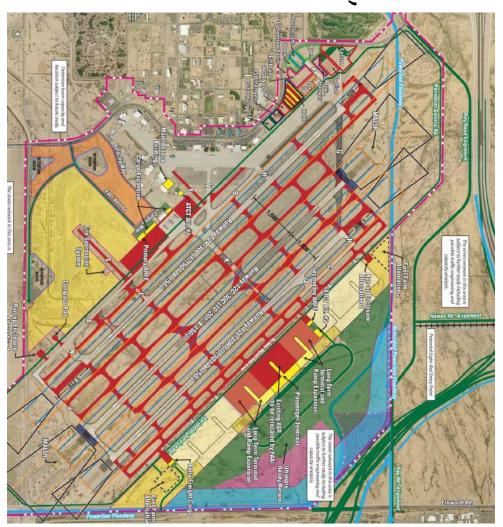
PMGA: Past, Present....Growing Success

- When closed in 1993: 3,800 jobs were lost with an impact of \$300M
- 2010 Economic Impact Study:
- 4,000 jobs, \$685M annual regional impact
- 212,00 visitors, 44 on airport employers
- 2014 Economic Impact Study:
- 10,400 jobs, \$1.3B annual regional impact
- 436,900 visitors, 51 on airport employers

Future..Continued Growth

Gateway Master Plan projects significant increases in new businesses/developments, employment, and commercial air travel



Financial Preparation for Growth

- capital member contributions to help fund operations and PMGAA member communities provide annual
- Mesa contributes 1.7M annually
- In total, the six member agencies have invested over \$120 million in the Airport
- Airport characterizes that amount as loans payable.
- The first maturity date of the loans is in 2020
- Most members book their contribution as an appropriation. Two of the six members book theirs as a receivable
- This situation unless remedied, will significantly limit PMGAA ability to secure funding for future capital projects

Proposed Solution & Recommendation

- Uctober 2014 to Working through 2014 with staffs from each of the member agencies, PMGA staff recommended to Gateway Board and received approval
- Recommend to each member agency Council's that they approve an amended cancelation agreement. and restated Joint Powers Airport Authority Agreement and associated loan
- Approval of the JPAAA would cancel past member loans and would characterize future member payments as contributions
- Enable PMGAA to re-characterize PMGAA \$120 million loans to cumulative appropriations
- that are necessary for future growth comprehensively plan, budget for, schedule, and construct improvements money for new infrastructure—specifically, to more effectively and This action would permit the Airport Authority in the future to borrow
- Staff recommends approval of the Amended JPAAA
