2. Approval of minutes from the June 28, 2018 meeting.

3. Conduct a public hearing on the following feasibility report:

3-a. Conduct a public hearing on the feasibility report for a proposed project to be financed by the issuance of general obligation bonds of the Cadence Community Facilities District.

It was moved by Boardmember Freeman, seconded by Boardmember Thompson that Resolution No. CFD CD Res 12 be adopted.
