

RESOLUTION NO. 10791

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA ADOPTING A NEW TECHNOLOGY ENHANCEMENT FEE AND MODIFYING SCHEDULES OF FEES AND CHARGES FOR THE BUSINESS SERVICES, POLICE, AND FIRE AND MEDICAL DEPARTMENTS.

WHEREAS, the City desires to adopt and assess a fee and charge for the purposes of funding enhancements in the technology used for the processing of various specialty licenses and permits to improve the experience of the City's customers,

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA, AS FOLLOWS:

Section 1: The Technology Enhancement Fee is hereby approved and adopted to be assessed on and along with those fees and charges presently adopted and existing and associated with the following Specialty Licenses and Permits: Carnivals and Tents, Fire Safety Operational Permit, Fortune Teller, Liquor and Special Event Liquor, Livestock, Massage Establishments, Massage Establishment Manager's License, Off-Track Betting, Park and Swap, Pawn Broker, Police Alarm Permit, Peddler, Pyrotechnics and Fireworks, Secondhand Dealer, Sexually Oriented Business, Sexually Oriented Business-Employee, Special Event, and Teen Dance Hall.

Section 2: The revised Schedules of Fees and Charges for the Business Services Department, Police Department, and Fire and Medical Department, which include the Technology Enhancement Fee, true and correct copies of which are attached hereto as Exhibit A and made a part hereof and incorporated herein by reference, are approved and hereby adopted to be effective on July 1, 2016. The Schedules are revised in Exhibit A to apply the Technology Enhancement Fee to the Specialty Permits and Licenses listed above as indicated through the addition of a bolded + symbol. Other changes to the text are shown in bold and capital letters: **ABC**. The new fee amount is also shown in bold: **\$2.00**.

Section 3: The various City officers and employees are hereby authorized and directed to perform all acts necessary to give effect to this Resolution.
