

RESOLUTION NO. 9942

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A FACILITIES USE AGREEMENT BETWEEN THE CITY OF MESA AND THE CHICAGO CUBS BASEBALL CLUB, LLC FOR USE OF THE NEW SPRING TRAINING FACILITIES.

WHEREAS, The Chicago Cubs has conducted its Spring Training at facilities located within the City of Mesa for 46 years, starting in 1952; and

WHEREAS, the City desires for the Chicago Cubs to continue to conduct their Spring Training activities in Mesa; and

WHEREAS, the Cactus League Spring Training is an important community asset providing significant economic benefits and community amenities for Mesa's citizens, businesses and visitors, as well as Maricopa County and the State of Arizona; and

WHEREAS, attendance at Cubs spring training games is generally higher than any other Cactus League team and generates significant tax revenue for the City of Mesa, Maricopa County and the State of Arizona; and

WHEREAS, the City and the Cubs have entered into a Development Agreement for the construction of a new Spring Training Facilities; and

WHEREAS, Cubs are willing and desire to continue their Spring Training in the new Spring Training Facilities, and to utilize the facilities as the Cubs West Coast Headquarters, subject to and in accordance with the terms and conditions of this Agreement; and

WHEREAS, a new stadium and training facility will spur additional economic and other beneficial development in the City and State; and

WHEREAS, in November 2010, the Mesa voters approved Proposition 420 which authorized the City to expend in excess of \$1.5 million for the construction of a new Spring Training Facility;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:**

Section 1: That the City Manager, Christopher J. Brady, or his designated representative, is authorized and directed to execute the Facilities Use Agreement on behalf of the City of Mesa, together with all other documents necessary to carry out the provisions of such agreement, and the City Clerk, Linda Crocker, or her designee, is authorized and directed to attest to the signature of the City Manager or his designated representative thereon.

Section 2: That the City Manager, Christopher J. Brady, or his designated representative, is further authorized to approve minor, administrative, technical or procedural modifications to the Facilities Use Agreement as needed.
