Informational Update on Recent Council Action:

At its August 25, 2014 meeting, the City Council acknowledged the receipt of the minutes of the June 17, 2014 Transportation Advisory Board meeting.

Informational Update on Recent Parking Prohibitions:

Approved on August 11, 2014 – modification to an existing 8:00 am to 4:00 pm school days parking prohibition to allow for on-street parking in front of a residence (west of Lindsay Road, north of Brown Road, Council District 1):

- On the east side of Gaylord from Glencove Street to a point 116 feet south of Glencove Street and on the west side from Brown Road to Glencove Street
- Approved on August 18, 2014 - modification to existing 8:00 am to 4:00 pm school days parking prohibitions to allow for on-street parking in front of residences (east of Alma School Road, north of University Drive, Council District 1).

- On the north side of 6th Street from Westwood to 6th Place and from a point 86 feet west of 6th Place to Emerson and on the south side from Westwood to a point 330 feet west of Westwood
- On the east side of 6th Place from 6th Street to a point 119 feet north of 6th Street and from a point 202 feet north of 6th Street to a point 383 feet north of 6th Street

Approved on September 25, 2014 – to improve visibility of eastbound traffic for northbound drivers exiting at driveway (west of Mesa Drive, north of Main Street, Council District 4).

- On the south side of 1st Street from a point 90 feet west of Wilbur to a point 50 feet east of Wilbur

Approved on October 8, 2014 - modification to existing 7:30 am to 3:30 pm school days parking prohibition to allow for curbside parent drop off and pick up adjacent to Meridian Elementary School (east of Signal Butte Road, south of Elliot Road, Council District 6).

- On the east side of Massey from Mesquite Street to a point 225 north of Mesquite Street
