Acting Chairman Jones announced that Boardmember Jamie resigned from the Fire Pension Board effective January 31<sup>st</sup>, 2017.

## 11. Discuss and consider the Accidental Disability Retirement application of Police Officer Nathan Peterson.

Acting Chairman Jones welcomed Police Officer Nathan Peterson to the meeting. She advised Officer Peterson that the members of the Local Board have reviewed his application and medical records. She outlined the process that would be followed by the Board and encouraged the members to pose any questions they may have regarding Officer Peterson's pending Accidental Disability application.

Discussion ensued relative to Officer Peterson's disabling injury and subsequent treatments.

Acting Chairman Jones advised Officer Peterson that the Local Board has reviewed the independent medical evaluation of Dr. Marc Dinowitz. She noted that Dr. Dinowitz is in agreement with the findings of Officer Peterson's attending physician, and that, in view of the absence of further questions from the Board, she would entertain a motion relative to this case.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the Accidental Disability Retirement application of Police Officer Nathan Peterson be approved.

Acting Chairman Jones declared the motion carried unanimously by those present.

Acting Chairman Jones thanked Police Officer Nathan Peterson for his service to the City.
