Acting Chair Jones excused Chairman Raines from the meeting.

POLICE PENSION BOARD

1. Certification of full-time Law Enforcement Officers pursuant to A.R.S. §§ 38-842.24(A), 38-842.27,38-842.31 and 38-847(D)1.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that Law Enforcement applicants Joshua Bruno, Samantha Escamilla, Eric Hendrix, and Robert Ravago be certified subject to the pre-existing medical conditions as noted.

Acting Chair Jones declared the motion carried unanimously by those present.

Acting Chair Jones declared the motion carried unanimously by those present.

6. Discuss and consider the Accidental Disability Retirement application of Police Officer Lauren Doane.

Acting Chair Jones welcomed Dwight Doane, representing Police Officer Lauren Doane. She advised Mr. Doane that the Local Board has reviewed the independent medical evaluations of Laura Don, M.D. and Glenn Clouse, Psy. D., and determined that both physicians are in agreement with the findings of Officer Doane's attending physicians.

Acting Chair Jones stated that in view of the absence of questions from the Board, she would entertain a motion relative to this case.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the Accidental Disability retirement application for Police Officer Lauren Doane be approved due to her having a permanent mental condition, caused by injury incurred while on duty, which totally prevents her from performing a reasonable range of duties within her job classification.

Acting Chair Jones declared the motion carried unanimously by those present.

Acting Chair Jones asked Mr. Doane to relay thanks to Officer Doane for her service to the City.

7. Discuss and consider the Accidental Disability Retirement application of Police Officer Roxana Meicke.

Police Officer Roxana Meicke was absent from the meeting.

Acting Chair Jones reported that the Local Board has reviewed the independent medical evaluations of Laura Don, M.D. and Glenn Clouse, Psy. D., and determined that there is a conflict of professional opinion between the Local Board Physicians. She added that the Local Board is required by statute to rely upon the professional opinion of a medical doctor, therefore to the extent that there had been a conflict in medical evidence, it is resolved by Dr. Don being a medical doctor and being in agreement with the findings of Officer Meicke's attending physicians.

Acting Chair Jones stated that in view of the absence of questions from the Board, she would entertain a motion relative to this case.

It was moved by Boardmember Lentz, seconded by Boardmember Russell, that the Accidental Disability retirement application for Police Officer Roxana Meicke be approved due to her having a permanent mental condition, caused by injury incurred while on duty, which totally prevents her from performing a reasonable range of duties within her job classification.

Acting Chair Jones declared the motion carried unanimously by those present.
