

ORDINANCE NO. 5044

AN ORDINANCE OF THE CITY OF MESA,  
MARICOPA COUNTY, ARIZONA, MODIFYING THE  
WATER SCHEDULES OF TERMS, RATES, FEES AND  
CHARGES RELATING TO CITY OWNED UTILITIES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESA,  
MARICOPA COUNTY, STATE OF ARIZONA, AS FOLLOWS:

SECTION 1: THAT THE SCHEDULES OF TERMS, RATES, FEES AND  
CHARGES FOR CITY-OWNED UTILITIES ARE HEREBY ESTABLISHED  
AND/OR AMENDED IN ACCORDANCE WITH THE FOLLOWING:

SECTION 2: THAT THE PENALTY CLAUSE IN SCHEDULE WHS IS  
HEREBY SET FORTH IN FULL IN ACCORDANCE WITH A.R.S. § 9-803:


Among other penalties that may apply, any person that violates any provision of  
this ordinance shall be guilty of a misdemeanor. Upon conviction, individuals  
shall be punished by a fine not to exceed \$2,500, or by imprisonment for a period  
not to exceed six (6) months, or by such fine and imprisonment. Upon  
conviction, businesses shall be punished by a fine not to exceed \$20,000. Each  
instance of violation shall be a separate offense, punishable as described above.
