

ORDINANCE NO. 5286

AN ORDINANCE OF THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, PERTAINING TO ADOPTION OF AMENDMENTS TO TITLE 5, CHAPTER 13, SECTION 2 OF THE MESA CITY CODE REGARDING THE LEVY OF A SOLID WASTE RESIDENTIAL DEVELOPMENT FEE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: ADOPTION OF AMENDMENTS TO TITLE 5, CHAPTER 13, SECTION 2 OF THE MESA CITY CODE. Mesa City Code subsection 5-13-2: Levy of Solid Waste Residential Development Fee is hereby amended and adopted to include the following revisions:

5-13-2: LEVY OF SOLID WASTE RESIDENTIAL DEVELOPMENT FEE:

There is hereby levied and shall be collected by the Building Safety Director, for the purpose of defraying costs of solid waste collection equipment required by the City as a result of residential development, an occupations fee upon every person constructing any dwelling unit or units or establishing manufactured home spaces or lots or recreational vehicle spaces or lots both inside and outside the City limits where the City of Mesa is the solid waste service provider. The fees shall be in the following amounts:

- (A) The sum of ~~one hundred ninety seven dollars (\$197.00)~~ **TWO HUNDRED TWENTY-SEVEN DOLLARS (\$227.00)** for each single-residence attached and detached dwelling unit hereafter constructed upon any lot or area.
- (B) The sum of sixty-two dollars (\$62.00) for each manufactured home space or lot, each recreational vehicle space or lot, and each multi-residence dwelling unit established.

Section 2: FORMAT OF REVISIONS. In Section 1 of this Ordinance, deletions to the text are shown as strike-outs: "~~Abe~~". Additions to the text are shown in bold and capital letters: "**ABC**".

Section 3: REPEAL OF CONFLICTING ORDINANCES. That all Ordinances or parts of Ordinances, and all sections of the Mesa City Code or parts of such sections in conflict herewith, are hereby repealed; provided that such repeal shall not: i) Affect suits pending, or rights and duties that matured or were existing, or penalties that were incurred and proceedings that were begun immediately prior to the effective date of this Ordinance; ii) Impair, void or affect and grant or conveyance made, or any right acquired, or a cause of action now existing under such repealed portions.


Section 4: SEVERABILITY. If any section, subsection, sentence clause, phrase or portion of this Ordinance or any part of the material adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of a Court of competent jurisdiction such decision shall not affect the validity of the remaining portions thereof.

Section 5: EFFECTIVE DATE. The effective date of this Ordinance shall be 30 days following adoption by the Mesa City Council.

Section 6: AUTHORIZATION. The various City officers and employees are hereby authorized and directed to perform all other acts necessary to carry out the intent and purpose of this Ordinance.
