The Mesa Housing Services Governing Board of the City of Mesa met in the Study Session room at City Hall, 20 East Main Street, on March 13, 2025, at 7:30 a.m.

Vice Chairperson Somers conducted a roll call.

Vice Chairperson Somers excused Chairperson Freeman from the entire meeting.

Vice Chairperson Somers led a moment of silence in honor of Transportation Director R.J. Zeder, who passed away last week.

Vice Chairperson Somers introduced and welcomed the new Resident Boardmember Rut Brea De La Vega.

1. Items from Citizens Present.

There were no items from citizens present.

2. Approval of minutes for the Mesa Housing Services Governing Board meeting held on May 16, 2024.

It was moved by Boardmember Spilsbury, seconded by Boardmember Duff, that the minutes from May 16, 2024, meeting be approved.

Upon tabulation of votes, it showed:

<u>3-a.</u> Hear a presentation and discuss the City of Mesa Public Housing Agency 2025-2029 Five Year <u>Plan, Annual Plan for FY 2025/2026, and updates regarding the City of Mesa Housing Choice</u> <u>Voucher program</u>.

Community Services Deputy Director Rosario Beltran displayed a PowerPoint presentation. **(See Attachment 1)**

Ms. Beltran explained the roles and responsibilities of the Mesa Housing Authority and provided an overview of the housing assistance programs that are offered by the Department of Housing and Urban Development (HUD) and administered by the City of Mesa (COM). (See Pages 2 through 4 of Attachment 1)

Responding to a question from Boardmember Duff, Ms. Beltran confirmed that there are currently 390 applicants on the waiting list for the Housing Choice Voucher program, which is approximately a three-year wait period.

Ms. Beltran confirmed that submitting a five-year plan is required by HUD and gives the agency and the COM a progress report of the program. She reviewed the updates made to the programs being offered and gave an overview of each. She highlighted the Family Self-Sufficiency program and pointed out that there were three COM families that graduated from the program this year. (See Pages 5 through 11 of Attachment 1)

In response to a question from Vice Chairperson Somers, Ms. Beltran stated that although there has been scrutiny of these programs at the federal level, the COM has not received any formal information from HUD indicating a reduction in funding. She confirmed that if any changes were made that will impact the COM, the Board would be consulted, and the plan could be revised if necessary.

Additional discussion ensued regarding the parameters and the benefits of each program offered.

In response to a question from Boardmember Duff, Ms. Beltran commented that the emergency vouchers that the COM received during the pandemic are the same as the Housing Choice Voucher program and explained that the program was continued after the pandemic ended.

Ms. Beltran provided an outline of the next steps and action items needed to submit the COM plans for approval.

Vice Chairperson Somers thanked staff for the presentation.

<u>4-a.</u> Conduct a public hearing on the City of Mesa Public Housing Agency's 2025-2029 Five-Year Plan and Annual Plan for FY2025/2026.

Vice Chairperson Somers announced that this is the time and place for a public hearing on the City of Mesa Public Housing Agency's 2025-2029 Five-Year Plan and Annual Plan for FY 2025/2026.

There being no citizens present wishing to speak on this issue, Chairperson Somers declared the public hearing closed.





Implementation Date:

- Effective January 1, 2025
 12-month notice of reduct
- 12-month notice of reduction required
- Mesa will continue applying "The 2 Year Rule" for changes in rent calculation that could have a negative effect on families by decreasing their subsidy.

Benefits:
