What is Community Court?



Person centric not crime centric



Focused on meeting the needs of our community members that are vulnerable



How is it different from other courts

How does the process work?

A restructuring of police procedures and policy on dealing with persons in need

Front line officers recognizing a person is better suited for services instead of incarceration

Initial appearance unlike any other court they have ever been to

- Court Started on July 2nd 2018
- Over 600 persons referred to the court by street officers
- 08/01/18-08/01/19 119 participants graduated from Community Court

What is Operation Off the Streets?




History

- Off the streets morphed from the Operation Main Line operations that the Mesa Police Department started back in 2018 with a new model of Outreach, Educate and Enforcement
- Due to COVID the city wanted a way to get a highrisk population off the street
- Started May 2020
- New feature was motel room use

How it worked

- Partnerships were made for housing and case management
- Officers contacted persons experiencing homelessness to offer service connection, educate them or enforce or a combination based on observed behavior.
- CBI Teams would respond and transport persons to motel.
- Involve other departments and partners



How it works now

- Officers contact persons in need and refer them to Paz
 De Cristo or in high needs situations contact me for
 other possible options.
- Mon-Fri Noon-7:00PM CBI has a navigator to connect them to motel or other shelter or housing options.
- This improved screening process has yielded better outcomes and more persons exiting homelessness
- Has evolved into the Mesa Way of reducing homelessness and is just the way our departments and partners do business on a day-to-day basis

Results

- May 2020 to December 31
- 4900+ Persons experiencing homelessness contacted and offered services by PD
- Over 2000 were a combination of services and community court referral
- 600 had behavior so egregious that a judicial solution was the only referral
- 434 immediately accepted services and were housed temporarily in the motel
- 188 of the 434 including 48 children transitioned out of the motel to a sustainable and stable housing environment.
- Results were sufficient for the City of Mesa to continue the program through 2021

2021 Emergency Rental/Utility Assistance Program

- \$15.7 million funded by the U.S. Treasury, Consolidated Appropriations Act of 2021
 - >\$14.1 million (90%) to Mesa residents who are financially impacted by COVID to prevent eviction and homelessness
 - ≥ 10% for program administration
