

COMMUNITY & CULTURAL DEVELOPMENT COMMITTEE MINUTES

February 24, 2025

The Community and Cultural Development Committee of the City of Mesa met in the Study Session room at City Hall, 20 East Main Street, on February 24, 2025, at 3:32 p.m.

Chairperson Spilsbury conducted a roll call.

1. Items from citizens present.

There were no items from citizens present.

2-a. Hear a presentation, discuss, and provide funding recommendations for the FY 2025/2026 and prior years' available funding for Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and Human Services Programs.

Deputy City Manager Candace Cannistraro explained that the annual funding process allocates federal and local funds and stated that the City of Mesa (COM) is expected to receive approximately the same amount that was received last year. She confirmed that if the amount of the grant funding is significantly different, staff will come back to the Committee to discuss how to distribute the funds.

Housing and Community Development Director Michelle Albanese introduced Housing and Community Development Administrator Justin Boyd and displayed a PowerPoint presentation. (See Attachment 1)

Ms. Albanese highlighted the strategic priorities set by the Council and confirmed that the projects that were selected align with all the priorities. She shared information about the Mesa Housing Path program and pointed out that a significant portion of the federal and local funds are utilized through this program to address homelessness in Mesa. She provided a timeline for the funding process and described the next steps. (See Pages 2 through 4 of Attachment 1)

Ms. Albanese addressed the improvements made to the funding process over the past year and highlighted the new scoring tool and criteria for staff to consider when reviewing the

applications. She provided a summary of the application review process. (See Pages 5 through 7 of Attachment 1)

In response to a question from Chairperson Spilsbury, Ms. Albanese confirmed that the COM is considered an entitlement community, which has made it easier to request and to receive grant funds. She confirmed that some cities choose to keep the grant funds to support their own homeless programs.

Ms. Albanese reported the Fiscal Year (FY) 25/26 estimated amounts to be allocated for the Community Development Block Grant (CDBG), Home Investment Partnership (HOME), Emergency Solutions Grant (ESG) and the Human Services programs. She provided the requested amount for grant funds received versus the available funding allocations for the programs. (See Pages 8 through 10 of Attachment 1)

Ms. Albanese outlined the CDBG public and non-public services, HOME, ESG, and Human Services/ABC programs that are recommended to receive allocated funds and the recommended award for each program. (See Pages 11 through 16 of Attachment 1)

Responding to a question from Chairperson Spilsbury, Ms. Albanese confirmed that the funds to be allocated must be used to serve the COM citizens only and explained the method used for verification.

Chairperson Spilsbury indicated that with the improvements and new scoring tools, she believes that the funding process is fair. She thanked staff for implementing changes based on feedback and providing agencies with opportunities to receive assistance with applications, presentations, and advice on the application process. She requested that staff provide the full Council with the list of agencies that requested and were not approved.

Ms. Albanese reviewed the next steps and stated that the funding recommendations would be submitted to the Department of Housing and Urban Development (HUD) by May 15, 2025. (See Page 17 of Attachment 1)

Chairperson Spilsbury thanked staff for the presentation.

It was moved by Committeemember Somers, seconded by Committeemember Duff, that the FY 2025/2026 and prior years' available funding recommendations for the CDBG, HOME, ESG, and Human Services programs be forwarded to full Council.

Upon tabulation of votes, it showed:






