Mayor's Welcome.

Mayor Giles conducted a roll call.

# \*3-f. <u>Arizona Distilling Co</u>

A spirituous liquor distillery is requesting a new Series 1 In-State Producer license for Copper City Spirits LLC, 155 West Main Street - Jason Keith Grossmiller, agent. There is no existing license at this location. **(District 4)** 

# \*3-g. <u>Aguila's Hidaway The Office</u>

A bar is requesting ownership transfer of the existing Series 6 Bar License for UFB Enterprise LLC, 330 South Gilbert Road Suites 2-3 - Javier Jimenez Aguila, agent. (District 4)

#### \*3-h. East Mesa Market

A convenience store is requesting a new Series 10 Beer and Wine Store License for Ora Investments LLC, 723 East Main Street - Jeffrey Craig Miller, agent. (District 4)

#### 4. Take action on the following contracts:

\*4-a. Two-Year Renewal to the Term Contract for General Motors (GM) Genuine Original Equipment Manufacturer (OEM) Auto and Light-Duty Truck Parts for the Fleet Services Department. **(Citywide)** 

Fleet Services has requested an increase for Years 4 and 5 to help offset an increase in parts pricing due to inflation. The contract is a percentage discount off the manufacturer's list price and as the list prices increase so does the total contract spend.

The Fleet Services Department and Purchasing recommend authorizing the renewal with Courtesy Chevrolet, Year 4 at \$700,000 annually and Year 5 at \$750,000 annually, based on estimated requirements.

\*4-b. Dollar Limit Increase and One-Year Renewal to the Term Contract for Heavy-Duty Original Equipment Manufacturer (OEM) Cab/Chassis Parts for the Fleet Services Department. (Citywide)

Fleet Services has requested an increase for Year 4 and an increase and renewal for Year 5 to help offset an increase in parts pricing due to inflation and increased use due to longer vehicle retention. This contract is set up with a percentage discount off manufacturer pricing; as manufacturer pricing continues to increase, so does the annual spend.

The Fleet Services Department and Purchasing recommend authorizing the renewal with Rush Truck Centers of Arizona dba Rush Truck Center Phoenix; Freightliner of Arizona, LLC dba Velocity Truck Centers; Inland Kenworth Inc.; RWC International dba RWC Group; and Cummins Inc. dba Cummins Sales and Service (a Mesa business); and increasing Year 4 by \$225,000 from \$825,000 to \$1,050,000 and renewing Year 5 at \$1,050,000, based on estimated requirements.

\*4-c. Five-Year Term Contract with Two Years of Renewal Options for Grounds Maintenance Equipment, Parts, Accessories, Supplies, and Related Services and Equipment for the Parks, Recreation and Community Facilities Department (PRCF). (Citywide)

Mesa, as the lead agency, solicited Request for Proposals in conjunction with Omnia Partners cooperative purchasing program. This contract will enable the City to maintain the current fleet of grounds maintenance equipment, purchase new equipment, and help keep the proper equipment inventory as more parks and sports fields come online. The resultant contract will benefit 40,000 plus member public agencies nationally, including state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit. The cooperative contract is a revenue source for the City as other agencies utilize this contract for their equipment purchases.

A committee representing PRCF and Purchasing evaluated responses and recommend awarding the contract to the highest scored proposal from The Toro Company, dba Toro, at \$352,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

# 5. Take action on the following resolutions:

- \*5-a. Approving and authorizing the City Manager to execute the necessary documents for the sale and title transfer of approximately 3,223 square feet of City-owned property located at the northwest corner of North Alma School Road and West 1st Place to the adjacent property owner. This portion of the parcel is a remnant parcel and cannot be developed as a standalone parcel. (District 3) Resolution No. 12095
- \*5-b. Approving and authorizing the City Manager to enter into a Grant Agreement with the Arizona Department of Public Safety to accept \$510,012 in Victims of Crime Act (VOCA) grant funds. The funding will be used for salaries and expenses for the Mesa Prosecutors Office, Victim Services Unit for a one-year period. (Citywide) Resolution No. 12096
- \*5-c. Approving and authorizing the City Manager to enter into an Intergovernmental Agreement with the Salt River Pima Maricopa Indian Community for the receipt and distribution of \$1,120,000 in Proposition 202 Funds. (Citywide) Resolution No. 12097

Under this Agreement, \$300,000 is awarded to the following City of Mesa programs: Fire and Medical Department, Immunization Program (\$100,000); Environmental and Sustainability, Trees for Heat Mitigation (\$48,000); Downtown Transformation, MacDonald Plaza Pilot Project (\$72,000); Mesa K-Ready, Kindergarten Readiness Program (\$40,000); and Arts and Cultural Department, Mesa Arts Center, MCA - Disadvantaged Artist Support (\$40,000).

The balance of the funds will be distributed to other local community agencies as passthrough grants.

- \*5-d. Extinguishing a portion of an easement for public utilities located at 570 West Brown Road to allow for the future construction of a new building on the property as requested by the developer. (**District 3**) – Resolution No. 12098
- 6. Take action on the following resolution and introduction of the following ordinance, and setting October 16, 2023, as the date of the public hearing on the ordinance:
  - \*6-a. Resolution declaring as a public record that certain documents have been filed with the City Clerk titled "Exhibit 1: 2023 Amendments to the Tables in Zoning Ordinance, Title 11, Chapters 5, 6, 7, 8, and 58 pertaining to drive-thru facilities and pick-up window facilities." (Citywide) Resolution No. 12099
  - \*6-b. Ordinance proposing Amendments to Chapters 5, 6, 7, 8, 31, 58, 86, and 87 of Title 11, Zoning Ordinance, of the Mesa City Code, pertaining to Drive-thru Facilities, Pick-up Window Facilities, and Drive-up ATM/Teller Windows. The amendments include, but are not limited to, repealing in its entirety Section 11-31-18 (Drive-thru Facilities) and replacing it with a new Section 11-31-18 (Drive-thru and Pick-up Window Facilities); modifying land use tables pertaining to Drive-thru Facilities, Pick-up Window Facilities, and Drive-up ATM/Teller Windows; removing definitions of Drive-thru Facilities and adding new definitions for Drive-thru Facilities, Pick-up Window Facilities, and Drive-up ATM/Teller Windows; Or Drive-thru Facilities, Pick-up Window Facilities, and Drive-up ATM/Teller Windows. (Citywide) Ordinance No. 5813
