Acting Chair Sheppard excused Chairman Raines from the meeting.

1. Approval of the minutes of the Public Safety Local Fire and Police Pension Boards meeting of December 16, 2021.

Subsequent to a review of all medical reports, Local Boardmembers requested the record reflect that applicants Daniel Brown, Cameron Cone, Zachary Flahive, Deven Gosha, Sara Khachame, Giuliano Nardulli, Nathan Rhodes, Nathan Szeneri, Nadine Tillawi, and Derric Webb have pre-existing medical conditions.

It was moved by Boardmember Lentz, seconded by Boardmember Russell that Law Enforcement applicants Daniel Brown, Cameron Cone, Zachary Flahive, Deven Gosha, Sara Khachame, Giuliano Nardulli, Nathan Rhodes, Nathan Szeneri, Nadine Tillawi, and Derric Webb be certified subject to the pre-existing medical conditions as noted.

Acting Chair Sheppard declared the motion carried unanimously by those present.

8. Discuss and take action on the Accidental Disability Retirement application of Police Officer Jacob Harris.

Acting Chair Sheppard welcomed Police Officer Jacob Harris to the meeting. She stated that the members of the Local Board have reviewed Officer Harris' application and medical records. She encouraged the members to pose any questions they may have regarding Officer Harris' pending Accidental Disability Retirement application.

Boardmember Russell thanked Officer Harris for continuing treatment during the sixty-day continuation and for the updated records provided to the Local Board.

Acting Chair Sheppard indicated that in view of the absence of questions from the Board, she would entertain a motion relative to this case.

It was moved by Boardmember Russell, seconded by Boardmember Lentz that Accidental Disability Retirement applicant Police Officer Jacob Harris be sent for Independent Medical Evaluations.

Upon tabulation of votes, it showed:

Discuss and take action on the Accidental Disability Retirement application of Police Officer Sean Stoddard.

Acting Chair Sheppard welcomed Police Officer Sean Stoddard to the meeting. She advised Officer Stoddard that the members of the Local Board have reviewed the Independent Medical Evaluation (IME) report from Dr. Jody Reiser. She encouraged Boardmembers to pose any questions they may have regarding Officer Stoddard's pending Accidental Disability Retirement application.

Boardmember Russell advised Officer Stoddard that the Local Board has reviewed the IME report from Dr. Jody Reiser. He indicated that Dr. Reiser agrees with the findings of Officer Stoddard's attending physician, that Officer Stoddard's condition was incurred in the performance of his duty, and that his condition totally and permanently prevents him from performing a reasonable range of duties within his job classification. He added that the Local Board has resolved any conflict regarding a pre-existing condition due to exposure in the military as there is no documentation that exposure in the military contributed at all to his current condition.

Local Board Attorney Cynthia Kelley expressed agreement with Boardmember Russell and stated that Officer Stoddard passed a pre-employment physical after being in the military and successfully performed his duties as a Police Officer for over a decade prior to the on-duty accident that solely caused his condition.

It was moved by Boardmember Russell, seconded by Boardmember Lentz that the Accidental Disability Retirement application of Police Officer Sean Stoddard be approved.

Upon tabulation of votes, it showed:

Acting Chair Sheppard declared the motion carried unanimously by those present.

Boardmember Brady thanked Officer Stoddard for his service to the City.
