1. Approval of the minutes of the Public Safety Local Fire and Police Pension Boards meeting of April 18, 2024.

### FIRE PENSION BOARD

3. Acknowledge receipt of PSPRS plan elections made by new hires.

The receipt of PSPRS plan elections made by new hires was acknowledged. (See attachment 1)

4. Discuss and take action on the Accidental Disability Retirement application of Firefighter Danna Taylor.

Acting Chairperson Sheppard advised the Local Board that Firefighter Danna Taylor is not in attendance. She stated that the Local Board has reviewed the IME of Dr. Doug Clouse. She encouraged the members to discuss and pose any questions they may have regarding the IME report.

Boardmember Castaneda read aloud supplemental questions and Dr. Clouse's responses as written in the IME report and requested his narrative be included in the minutes as public record.

Question 1: Please review the VA document that identifies the percentage of disability, specifically as it relates to left shoulder injuries, and explain the degree to which those service-connected disabilities contributed to the current injury.

Response: The newly provided documentation from the Department of Veterans Affairs shows that two of her left shoulder injuries were service connected. It outlined a disability rating of 20% as a relates to glenohumeral joint instability, residuals of left shoulder arthroscopy with anterior posterior capsulorrhaphy, and capsular plication (non-dominant). There is also a report of an additional disability rating of 20% with the diagnosis of left shoulder subluxation (non-dominant). Both diagnoses were related to the original injury in 2012 following her capsulorrhaphy surgery and 2019 surgery of a posterior labral repair.

However, this does not change my original opinion as stated in my previous IME. Ms. Taylor had evidence of a pre-existing condition of left shoulder instability and a posterior labral tear which were successfully treated with surgery and was stable in the time leading up to the work-related injury in 2021. In my opinion, the 2021 left

shoulder injury represented a new injury which caused an aggravation (a permanent worsening) of her pre-existing condition. It is reasonable to conclude that Ms. Taylor may have had some residual deficits as it relates to capsular laxity and to the posterior labrum following her two shoulder surgeries as she received a disability rating from the VA. However, these did not appear to significantly limit her activities as she was able to return to full use of the shoulder, including being able to perform all the duties required to be a firefighter for several years after both procedures. Following her 2021 injury and her subsequent two surgeries, she has developed a permanent worsening of her left shoulder with chronic shoulder pain, limited range of motion, and a musculocutaneous nerve injury.

In addition, I am in agreement with Dr. Steingart that the 2012 shoulder instability was more of a capsular laxity issue and not a result of a labral tear. The 2019 shoulder injury was related to the posterior labrum. The 2021 left shoulder injury was the result of an acute dislocation causing an anterior labral tear that was both seen in imaging studies and at the time of surgery. This represents a new and separate site of injury compared to the 2012 (capsular laxity) and 2019 (posterior labral tear) injuries.

Therefore, Ms. Taylor had a pre-existing condition of capsular laxity and a posterior labral tear that were successfully treated with surgery and was stable and was able to actively participate in her duties as a firefighter. The 2021 left shoulder injury that she sustained while working as a firefighter for the City of Mesa represents a new injury causing an aggravation (a permanent worsening) of her previously stable pre-existing condition.

Question 2: To what extent is the current injury the same or different from the injury incurred in the military?

Response: The injury that Ms. Taylor sustained in 2012 represents more capsular laxity causing her shoulder symptoms. There were no reports of any labral tears at that time, and she was treated with a capsulorrhaphy procedure which tightens the capsule to limit any excess shoulder motion. The fact that Ms. Taylor was able to return to full duty as a firefighter for several years without any further shoulder problem indicates that the shoulder treatment was successful. There were also no signs of any abnormal articular damage in the shoulder to support this as well.

The 2019 left shoulder injury was related to the posterior labrum. This could be debated if this was related to the previous 2012 injury or more of a work-related injury from her firefighting duties. Ms. Taylor chose to go through the VA with this issue which was awarded a disability rating. This was also successfully treated with surgery allowing her to return to full activities.

The 2021 left shoulder injury was the result of an acute shoulder dislocation due to the stress applied to the shoulder as she was moving a heavy patient in an emergency situation. The MRI showed an anterior labral tear with a corresponding Hill-Sachs defect confirming an acute dislocation injury. Her mechanism of injury is different compared to her previous injuries. The location of her damaged tissue is also different from the 2012 and 2019 left shoulder injuries.

Boardmembers stated that the IME report clearly separates the military and work-related injuries and indicates that the work-related injury exacerbated Ms. Taylor's pre-existing condition to the point where she is now permanently unable to perform a reasonable range of duties within her job classification.

It was moved by Boardmember Castaneda, seconded by Boardmember Silides, that the Accidental Disability Retirement application of Firefighter Danna Taylor be approved.

Upon tabulation of votes, it showed:

Acting Chairperson Sheppard declared the motion carried unanimously by those present.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that Law Enforcement applicants Alejandro Barahona, Lilly Conn, Daniel DeHoyos, Jeffry Dupont, Cole Kurian, Jesse Macias, Jalen Shatswell, Caleb Skiffington, Andrew Talley, and Kimberly Willhite be certified subject to the pre-existing medical conditions as noted.

## 7. Discuss and take action on the rehire of retired PSPRS member Cory Moe to Commercial Motor Vehicle Safety Technician (Temporary Agency Assignment).

Human Resources Director Teri Overbey stated that Cory Moe retired as a Police Officer effective 02/01/2024 and recently competed in an open, competitive recruitment process for the civilian, non-supervisory, non-PSPRS, temporary position of Commercial Motor Vehicle Safety Technician.

It was moved by Boardmember Lentz, seconded by Boardmember Russell, that the rehire of retired PSPRS member Cory Moe to Commercial Motor Vehicle Safety Technician (Temporary Agency Assignment), with an effective date to be determined, be approved as within the statutory requirements and that no alternate contribution will need to be paid.

Discussion ensued relative to Officer Covington's efforts to gather documentation of his diagnosis, ongoing treatment, and prognosis. Boardmembers advised Officer Covington to continue treatment and to provide records indicating the professional medical opinions of his treating physicians as they become available. Boardmembers commented that they do not wish to cause Officer Convington additional stress and are willing to table his application until he has completed enough treatment to be able to provide such records.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the Accidental Disability Retirement application of Police Officer Jeffrey Covington be tabled.
