If you want to request to speak telephonically at the meeting, please submit an comment card at least 24 hours prior to the start of the meeting. You will need to indicate on the comment card that you would like to speak during the meeting, and you will need to call 888-788-0099 or 877-853-5247 (toll free) using meeting ID 5301232921 and follow the prompts, prior to the start of the meeting. You will be able to listen to the meeting and when the item you have indicated that you want to speak on is before the Board, you will be prompted to unmute yourself and you will be given an opportunity to speak. The Judicial Advisory Board may move into Executive Session for deliberation purposes.
