Human Resources Administrator Melissa Green stated that Jeffrey Ehrlich retired as a Fire Captain with Superstition Fire effective August 2023 and recently competed in an open, competitive recruitment process for the civilian, non-supervisory, non-PSPRS position of Emergency Medical Services Coordinator.

It was moved by Boardmember Castaneda, seconded by Boardmember Fifield, that the re-hire of retired PSPRS member Jeffrey Ehrlich, to Emergency Medical Services (EMS) Coordinator, with an effective date to be determined, be approved as within the statutory requirements and that no alternate contribution will need to be paid.

Human Resources Administrator Melissa Green confirmed that Joshua Grandinetti is still employed with the City of Eloy and is scheduled for their Local Fire Pension Board agenda on March 27, 2025 for his retirement at the end of this month.

Boardmember Castaneda inquired if Mr. Grandinetti was retiring by means of disability and recommended that information be obtained prior to approving the re-hire to protect the best interest of the applicant and the City of Mesa.

It was moved by Boardmember Fifield, seconded by Boardmember Castaneda, that the re-hire of retired PSPRS member Joshua Grandinetti, to Civilian Paramedic, be continued until it can be verified under what conditions Mr. Grandinetti will be retiring from the City of Eloy.
