(Items on the agenda were discussed out of order, but for the purposes of clarity will remain as listed on the agenda.)

1. Approval of the minutes of the Public Safety Local Fire and Police Pension Boards meeting of April 21, 2022.

It was moved by Boardmember Sheppard, seconded by Boardmember Lentz, that the minutes of the Public Safety Local Fire and Police Pension Boards meeting of April 21, 2022 be approved.

Upon tabulation of votes, it showed:

### 2. Discuss and consider supplements to the PSPRS Revised Model Uniform Rules of Local Board Procedure.

Local Board Attorney Cynthia Kelley presented additions and modifications suggested by legal counsel in order to accommodate the Mesa Local Board.

Boardmember Russell advised that the supplements appear to be sufficient, with the exception of one error which lists the City of Phoenix where it should list the City of Mesa. He indicated that he would be willing to make a motion to approve the revised procedures with the stipulation that the error be corrected.

It was moved by Boardmember Russell, seconded by Boardmember Castaneda, that the supplements to the PSPRS Revised Model Uniform Rules of Local Board Procedure be approved with one correction.

3. Discuss and take action on the Ordinary Disability Retirement application of Firefighter Blu Caton.

Chairperson Raines welcomed Firefighter Blu Caton to the meeting. He stated that the members of the Local Board have reviewed Mr. Caton's application and medical records. He encouraged the members to pose any questions they may have regarding Mr. Caton's pending Ordinary Disability Retirement application.

Discussion ensued relative to events leading to Mr. Caton's injuries, subsequent treatments, and current condition.

Chairperson Raines indicated that in view of the absence of further questions from the Board, he would entertain a motion relative to this case.

It was moved by Boardmember Castaneda, seconded by Boardmember Silides, that Ordinary Disability Retirement applicant Firefighter Blu Caton be sent for an Independent Medical Evaluation.

Upon tabulation of votes, it showed:

#### 4. Acknowledge receipt of PSPRS plan elections made by new hires.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that receipt of PSPRS plan elections made by new hires (**See Attachment 1**) be acknowledged.

# 5. Certification of full-time Law Enforcement Officers pursuant to A.R.S. § 38-842.24(A), 38-842.27, 38-842.31 and 38-847(D)1.

Subsequent to a review of all medical reports, Local Boardmembers requested the record reflect that applicants Gavin Ashlin, Vido Barino, Kane Davalos, Mason Hammel, Christopher Parisian, Jordan Perez, Christopher Phillips, and Joshua Sanchez have pre-existing medical conditions.

It was moved by Boardmember Lentz, seconded by Boardmember Russell, that Law Enforcement applicants Gavin Ashlin, Vido Barino, Kane Davalos, Mason Hammel, Christopher Parisian, Jordan Perez, Christopher Phillips, and Joshua Sanchez, be certified subject to the pre-existing medical conditions as noted.

Upon tabulation of votes, it showed:

# 6. Discuss and take action on the reclassification of re-hired PSPRS member Richard Gogoiu to Civilian Teleserve Officer.

Human Resources Director Teri Overbey stated that Richard Gogoiu retired effective 7/1/2018, he was rehired as a Municipal Security Officer effective 12/20/2021, and after competing in an open, competitive recruitment process, he has been offered the non-PSPRS position of Civilian Teleserve Officer.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the reclassification of re-hired PSPRS member Richard Gogoiu to Civilian Teleserve Officer, effective 5/23/2022, be approved as within the statute requirements and that no alternate contribution will need to be paid.

Upon tabulation of votes, it showed:

# 7. Discuss and take action on the Accidental Disability Retirement application of Police Officer Jodi Valcik.

Chairperson Raines welcomed Police Officer Jodi Valcik to the meeting. He stated that the members of the Local Board have reviewed Officer Valcik's application and medical records. He encouraged the members to pose any questions they may have regarding Officer Valcik's pending Accidental Disability Retirement application.

Discussion ensued relative to Officer Valcik's injuries, subsequent treatments, and current condition.

Boardmember Russell expressed concern regarding the length of time between the on-duty incident Officer Valcik indicated as the cause of her injuries and the onset of symptoms. He indicated that her doctors did not state that her injuries were caused by the reported incident. He suggested that Officer Valcik seek additional documentation from her doctors to indicate the cause of her injuries and current condition.

Officer Valcik stated that she has scheduled an appointment with another doctor for a second opinion and would be willing to come back before the Board with additional documentation at a future meeting.

Chairperson Raines indicated that in view of the absence of further questions from the Board, he would entertain a motion relative to this case.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the Accidental Disability Retirement application of Police Officer Jodi Valcik be continued until Officer Valcik provides additional documentation to the Board.

Upon tabulation of votes, it showed:
