# Meeting called to order and roll call.

Chairperson Cattani called the meeting to order at 7:47 a.m. and conducted a roll call.

## 3. Items from citizens present.

Patricia George, Phoenix Municipal Court Judge, spoke in support of Kerry Rait. She commented that she has worked with Ms. Rait in multiple capacities over the past 20 years, observing her personally in a professional setting. She mentioned Ms. Rait's extensive experience in the Prosecutor's office, specifically showcasing her knowledge of charging, is a testament to her qualifications. She indicated that Ms. Rait exhibits a calm demeanor and could seamlessly transition into the position.

Kristin Culbertson, Maricopa County Superior Court Judge, provided comments supporting Kevin Breger. She noted Mr. Breger has an excellent work ethic and serves on the State Bar of Arizona Animal Law Executive Council.
