Boardmember Silides advised Mr. Madrid that the Local Board has reviewed the IME report from Dr. Giraldo Kato. He indicated that Dr. Kato agrees with the findings of Mr. Madrid's attending physician, that Mr. Madrid's condition was incurred in the performance of his duty, and that his condition totally and permanently prevents him from performing a reasonable range of duties within his job classification.

Human Resources Director Teri Overbey stated that Frank Hoglund retired in March of 2017, he was rehired as a Code Compliance Officer I on 9/24/2018, was promoted to Code Compliance Officer II on 5/10/2021, and after competing in an open, competitive recruitment process, he has been offered the position of Code Compliance Supervisor.

It was moved by Boardmember Lentz, seconded by Boardmember Brady that the reclassification of re-hired PSPRS member Frank Hoglund to Code Compliance Supervisor, effective 9/20/2021, be approved as within the statute requirements and that no alternate contribution will need to be paid.
