Human Resources Director Teri Overbey stated that Dale Jernegan retired as a Police Officer effective 4/1/2023 and has been offered a position through a temporary agency to assist with the inventory and move of evidence to a new facility for a period of up to two years.

It was moved by Boardmember Lentz, seconded by Boardmember Russell, that the temporary rehire of retired PSPRS member Dale Jernegan to Evidence Technician be approved, as within the statutory requirements for a period not to exceed twenty-four months, effective 7/24/2023, and that no alternate contribution will need to be paid.

8. Discuss and take action on the Accidental Disability Retirement application of Police Officer Curtis Simpson.

Chairperson Mickelsen welcomed Police Officer Curtis Simpson to the meeting. She encouraged the members to pose any questions they may have regarding Officer Simpson's pending Accidental Disability Retirement application.

Boardmember Russell stated that the Local Board has reviewed the independent medical evaluation (IME) of Dr. D. Gregory Stewart. He indicated that Dr. Stewart's report was very clear.

Boardmember Lentz expressed his agreement regarding the clarity of the IME report.

Chairperson Mickelsen advised that Dr. Stewart agrees with the findings of Officer Simpson's attending physician, that Officer Simpson's condition was incurred in the performance of his duty, and his condition totally and permanently prevents him from performing a reasonable range of duties within his job classification. She added that in view of the absence of questions from the Board, she would entertain a motion relative to this case.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the Accidental Disability Retirement application of Police Officer Curtis Simpson be approved.

Upon tabulation of votes, it showed:

Chairperson Mickelsen and Boardmember Brady thanked Police Officer Curtis Simpson for his service to the City.
