



PARTICIPATING AND ATTENDING MEETINGS

The public may attend the Judicial Advisory Board meetings in person, or listen to the meeting telephonically. Members of the public who attend a meeting in person or telephonically are welcome and encouraged to participate by speaking during agenda items; however, the opportunity to address the Judicial Advisory Board during "Items from Citizens Present" will not be available telephonically as it is reserved for those who are present at the meeting, attending in person.

The meeting will be accessible telephonically by calling **888-788-0099 or 877-853-5247** (toll free) using meeting **ID 82508085605** and follow the prompts.

If present, submit a comment card to the Deputy City Clerk prior to the start of the meeting to speak on an agenda item. If you want to request to speak telephonically on an agenda item other than "Items from Citizens present," please submit an [online comment card](#) at **least 24 hours prior to the start of the meeting**. You will need to indicate on the comment card that you would like to speak during the meeting, provide a phone number for identification, and you will need to call **888-788-0099 or 877-853-5247 (toll free) using meeting ID 82508085605 and follow the prompts, prior to the start of the meeting**. You will be able to listen to the meeting and when the item you have indicated that you want to speak on is before the Board, you will be prompted to unmute yourself and you will be given an opportunity to speak. The Judicial Advisory Board may move into Executive Session for deliberation purposes.
