MINUTES PERSONNEL APPEALS PRE-HEARING APPELLANT: Jennifer Holder-Schoolcraft

Monday, September 21, 2020

A Pre-Hearing regarding the appeal of dismissal by Jennifer Holder-Schoolcraft was held at 4:02 p.m., Monday, September 21, via video conference.

MEMBERS PRESENT

Nick McLain, Personnel Appeals Board Chair Justin Pierce, Counsel for the City Kathryn Hackett King, Board Counsel Jennifer Holder-Schoolcraft, Appellant Tracy Hurt, Board Secretary

The meeting was called to order at 4:02 p.m. by Mr. McLain, Appeals Board Chair.

The first order of business was to review the list of witnesses and exhibits submitted by each party.

Mr. Pierce opposed the witness statement provided by Ms. Holder-Schoolcraft being included since there could be no cross examination. In addition, he noted it is unsigned and dated 2018 so it was not prepared for the Board and does not have indicia of reliability.

Ms. Holder-Schoolcraft asked if it would be admissible if she got a signature, and she explained the date of the letter is wrong and should be 2019. She indicated that the employee is afraid of retaliation should she appear as a witness at the hearing.

Mr. Pierce explained that fear of retaliation cannot be a reason to allow a statement in lieu of testimony because the witness needs to be subject to cross examination.

Ms. Holder-Schoolcraft asked if there was an opportunity to add the witness to the list should she agree to testify.

Mr. Pierce had no objection to adding the individual as a late-disclosed witness. He indicated he would need to know whether she would testify in-person within the next week. Mr. Pierce inquired if Ms. Holder-Schoolcraft is expecting to testify herself since she is not represented by a lawyer and she confirmed she would be testifying.

Mr. McLain asked if Ms. Holder-Schoolcraft preferred the hearing to occur in an open public meeting or in executive session, noting it may make it easier for the witness to appear if it was not an open public meeting. Mr. Pierce noted that even if a hearing occurred in executive session, he would still have a representative present from the work group during the hearing.

Mr. McLain advised Ms. Holder-Schoolcraft that she would have the until close of business on September 28, 2020 to notify Ms. Hurt with her preference regarding whether the hearing would occur in an open public meeting or in executive session and the witness addition.
