

# JUDICIAL ADVISORY BOARD MINUTES

September 18, 2019

The Judicial Advisory Board of the City of Mesa met in the lower level meeting room of the Council Chambers, 57 East 1st Street, on September 18, 2019 at 7:50 a.m.

Chairperson Swanson excused Boardmember Costa from the beginning of the meeting; she arrived at 7:53 a.m.

### 1. Meeting called to order.

Chairperson Swanson called the meeting to order at 7:50 a.m.

#### Approve minutes from the August 7, 2019 meeting.

It was moved by Boardmember Kiley, seconded by Boardmember Humphrey, that the minutes from August 7, 2019 be approved.

#### 3. Items from citizens present.

Stasy Click, a Phoenix resident, offered a series of comments in support of City Magistrate candidate Dianne Sullivan. She advised she has been an attorney for 25 years as a prosecutor,

judge pro tem and family law attorney and has known Ms. Sullivan for many years. She explained when she was a new defense attorney Ms. Sullivan helped guide her. She described Ms. Sullivan as being very professional and her reputation in family law is extraordinary. She expressed the opinion that Ms. Sullivan is well-trained for the position and would make an excellent judge because she can handle with a high volume of cases.

Chris Kent, a Scottsdale resident who works in real estate, offered comments in support of City Magistrate candidate Dianne Sullivan. She described Ms. Sullivan as being capable of getting the job done with great care and respect, being very decisive, and full of conviction and passion. She stated as a friend and associate she would recommend Ms. Sullivan for the position as City Magistrate because she is fair, honest and will get the job done.

Presiding Magistrate Matt Tafoya described the list of candidates and stated the best candidate is one who possesses lower court experience and a connection with the City of Mesa. He thanked the Boardmembers for their time and direction to the process.
