Chairperson Mickelsen excused Boardmember Brady from the beginning of the meeting. He arrived at 11:05 a.m.

POLICE PENSION BOARD

1. Acknowledge receipt of PSPRS plan elections made by new hires.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the PSPRS plan elections made by new hires (**See Attachment 1**) be acknowledged.

Upon tabulation of votes, it showed:

Carried unanimously.

Certification of full-time Law Enforcement Officers pursuant to A.R.S. §§ 38-842.24(A), 38-842.27, 38-842.31 and 38-847(D)1.

Subsequent to a review of all medical reports, Local Boardmembers requested the record reflect that applicants Sean Bazacas, Gavin Caldwell, Elijah Dorsten, Hennessey Evans, Naythanyal Herrera, Samuel Ichrist, Uriel Jimenez Salazar, Arturo Martinez, Landon Moncada, Taryll Sumler, and Jerimiah Wiltfang have pre-existing medical conditions.

It was moved by Boardmember Lentz, seconded by Boardmember Russell, that Law Enforcement applicants Sean Bazacas, Gavin Caldwell, Elijah Dorsten, Hennessey Evans, Naythanyal Herrera, Samuel Ichrist, Uriel Jimenez Salazar, Arturo Martinez, Landon Moncada, Taryll Sumler, and Jerimiah Wiltfang be certified subject to the pre-existing medical conditions as noted.

Upon tabulation of votes, it showed:

3. Discuss and take action on the rehire of retired PSPRS member Walter Landvatter to Mail and Delivery Worker (Part-time).

Chairperson Mickelsen advised that Walter Landvatter retired in March 2021 as a Police Officer and is being rehired as a Mail and Delivery Worker, a substantially different position.

Boardmember Russell expressed agreement that the positions are substantially different according to the job descriptions.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that the rehire of retired PSPRS member Walter Landvatter to Mail and Delivery Worker (Part-time) be approved as within the statute requirements and that no alternate contribution will need to be paid.

Upon tabulation of votes, it showed:

4. <u>Discuss and take action on the Accidental Disability Retirement application of Police Officer</u> Patrick Kreuzer.

Chairperson Mickelsen welcomed Police Officer Patrick Kreuzer to the meeting. She thanked Officer Kreuzer for providing VA medical paperwork as requested at the last meeting.

Boardmember Russell advised that the additional paperwork needs to be sent to Dr. Lisa Jones along with some questions from the Local Board.

Discuss and take action on the Accidental Disability Retirement application of Police Officer Curtis Simpson.

She encouraged the members to pose any questions they may have regarding Officer Simpson's pending Accidental Disability Retirement application.

It was moved by Boardmember Russell, seconded by Boardmember Lentz, that Accidental Disability Retirement applicant, Police Officer Curtis Simpson, be sent for an Independent Medical Evaluation.
