## **ORDINANCE NO. 5934**

AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, PURSUANT TO THE PROVISIONS OF ARTICLE 7, CHAPTER 4 OF TITLE 9, ARIZONA REVISED STATUTES AND AMENDMENTS THERETO, BY ANNEXING CERTAIN COUNTY RIGHT-OF-WAY ADJACENT TO THE EXISTING CITY LIMITS AND TRANSFERRING THE RIGHT-OF-WAY INTO THE CITY OF MESA.

WHEREAS, the City of Mesa ("City") desires to annex into the City that certain Maricopa County ("County") right-of-way located along South 222<sup>nd</sup> Street from East Pecos Road and extending approximately 2,200 feet north, more particularly described in <u>Section 1</u> below and shown on the map attached to this Ordinance as Exhibit A ("Property"); and

WHEREAS, the Property consists solely of County right-of-way or roadway with no taxable real property; and

WHEREAS, the entire length of the Property is adjacent to the corporate boundaries of the City; and

WHEREAS, the annexation statute, A.R.S. § 9-471(O), permits the transfer of county right-of-way or roadway from an unincorporated area within the county to the corporate limits of a city by mutual consent of the governing bodies of the city and the county; and

WHEREAS, the annexation of the Property and transfer to the City of Mesa is subject to approval by the Maricopa County Board of Supervisors at a future public meeting; and

WHEREAS, upon approval by the Maricopa County Board of Supervisors, the Property will be treated by the City of Mesa as newly annexed territory.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESA MARICOPA COUNTY, ARIZONA, AS FOLLOWS;

<u>Section 1</u>: That the Property described below and shown on the map attached as Exhibit A, incorporated herein by this reference, is hereby annexed to the City of Mesa and the present corporate limits are hereby extended and increased to include the Property upon approval by the Maricopa County Board of Supervisors at an upcoming public meeting. Following approval of the Maricopa County Board of Supervisors, the Property is transferred to the City of Mesa and shall be treated by the City of Mesa as newly annexed territory.

A portion of the southeast quarter of Section 35, Township 1 south, Range 7 east of the Gila and Salt River Base and Meridian, Maricopa County, Arizona, more particularly described as follows:

Commencing at the south quarter corner of said Section 35, from which the southeast corner of said Section 35 bears south 89°27'38" east, a distance of 2643.31 feet;

Thence along the south line of the southeast quarter of said Section 35, south 89°27'38" east, a distance of 1291.11 feet;

Thence leaving said south line, north 00°32'22" east, a distance of 33.00 feet to the point of beginning;

Thence north 00°24'12" west, a distance of 2201.11 feet to the beginning of a curve concave southwesterly having a radius of 20.00 feet;

Thence northwesterly along the arc of said curve, to the left, through a central angle of 53°58'05", an arc length of 18.84 feet to the beginning of a reverse curve whose radius bears north 35°37'42" east, a distance of 65.00 feet;

Thence northerly, easterly and southerly along the arc of said curve, to the right, through a central angle of 287°56'10", an arc length of 326.65 feet to the beginning of a reverse curve whose radius bears south 36°26'07" east, a distance of 20.00 feet;

Thence southwesterly along the arc of said curve, to the left, through a central angle of 53°58'05", an arc length of 18.84 feet;

Thence south 00°24'12" east, a distance of 2202.10 feet;

Thence north 89°27'38" west, a distance of 60.01 feet to the point of beginning.

Containing 145,773 sq. ft. or 3.346 acres more or less

<u>Section 2</u>: That the City Clerk is hereby authorized and directed to forward a copy of this Ordinance and the map attached as Exhibit A to the Maricopa Board of Supervisors.

<u>Section 3</u>: RECITALS. The recitals above are fully incorporated in this Ordinance by reference.

<u>Section 4</u>: EFFECTIVE DATE. That this Ordinance shall take effect upon the occurrence of all of the following:

- a. Adoption of an ordinance by the County Board of Supervisors transferring the Property to the City;
- b. A copy of this Ordinance and the ordinance approved by the County, together with Exhibit A, being filed and recorded in the Office of the County Recorder of Maricopa County, Arizona; and
- c. Thirty (30) days following the adoption of this Ordinance by the City Council.
