## **ORDINANCE NO. 5923**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA ADOPTING TITLES AND SCHEDULES OF TERMS, RATES, FEES AND CHARGES FOR CITY-OWNED NATURAL GAS UTILITIES.

Whereas on December 2, 2024, the City Council adopted Ordinance No. 5898 that adjusted certain city-owned natural gas utilities rates, fees and charges.

Whereas Ordinance No. 5898 had a couple typographical errors unrelated to the natural gas utilities rates, fees and charges adopted in that ordinance; but to fix these typographical errors and to ensure clarity, this ordinance is re-adopting the same natural gas utilities rates, fees and charges and correcting the typographical errors.

Whereas, in summary, the rates, fees and charges adopted this Ordinance are the same as the rates, fees and charges adopted Ordinance No. 5898, and the only changes are to correct typographical errors.

BE IT ORDAINED by the City Council of the City of Mesa, Maricopa County, State of Arizona, as follows:

Section 1: That the following Titles and Schedules of Terms, Rates, Fees and Charges for City-Owned Natural Gas Utilities, as made public record by Resolution No. 12298 adopted on November 18, 2024, three copies of which are on file and available for public use and inspection with the Office of the City Clerk, are hereby established or amended and adopted to be applicable for monthly billing cycles commencing on and after the effective date of this Ordinance:
